

inVest48 Sweepstakes Rules

No purchase is necessary to enter or win. A purchase does not increase the chances of winning.

Eligibility: Credit Unions Rise Sweepstakes (the “Sweepstakes”) is open to legal residents of the 50 United States and the District of Columbia who are 18 years of age or older at the time of entry.

Agreement to Rules: By participating, you agree to be fully unconditionally bound by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein.
